

Samsung Rewards Winter Instant Win Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Follow the links and instructions to proceed to the Rewards Catalog. Locate an available prize offered in this Instant Win Game and follow the directions to redeem the required number of Points and you will receive one (1) Instant Win Game play for the selected prize.
